Forks and load handling attachments: Check that the forks are not cracked, bent, worn or mismatched. Ensure there is no hesitation when hoisting or lowering the forks, when using the forward or backward tilt, or the lateral travel on the side shaft. OK Action required Check there is no excessive oil or water on the forks. Hydraulic system: Check there are no cracks or damage on the lift, tilt and attachment functions of the cylinders. Ensure fluid Action required levels are ok. Action required Overhead guards: Check there are no broken welds, missing bolts or damaged areas. **Mast assembly:** Check there are no broken welds, cracked or bent areas and worn or missing stops. OK Action required OK Action required Lift chains and rollers: Check there is no wear, damage, kinks, signs of rust or any signs that lubrication is required eq squeaking. **Tires:** Check there are no cuts, large pieces of rubber missing or that the tire has not separated from the rim. OK | Action required Steering: Check there is no excessive free play. If there is power steering, check pump is working. Lights: Check lights are working correctly.	OK Action required
Horn/Reversing alarm: Check that horn and reversing alarm sounds and works correctly.	OK Action required
Seat: Ensure that the seat is secure and installed correctly.	OK Action required
<b>LPG tank, hose and odour:</b> Check that the tank guard bracket is properly positioned and locked down. Check the hose is not damaged eg frayed, pinched, kinked or bound in anyway. Make sure connector is threaded on squarely and tightly. Ensure there is no LPG gas odour. If you detect LPG odour, turn off the tank valve and report to your supervisor.	N/A OK Action required
Safety Belt: Ensure safety belt is in good condition and running smoothly.	N/A OK Action required
Tow hook: Check that it engages, releases smoothly and that the safety catches work properly.	N/A OK Action required
<b>Battery charging station:</b> Ensure you use the appropriate PPE gear and are not wearing metallic jewellery when working in the designated charging station area. Check water and electrolyte levels of battery before charge and record levels in log book. Check water levels after charge and top up if required. Turn off the charger if battery becomes hot or electrolyte fluid comes out of battery, and restart charge at a lower rate. Care shall be taken to assure that vent caps are functioning.
